- 4 To pay attendance dues at a rate determined by the Proprietor and approved by the Ministry of Education.
 - *The Archdiocese of Wellington will send out four invoices throughout the year, the first on or about 1 March, for the total family attendance dues to be paid.*
 - *In the event of default in payment of dues, then recovery costs will be an additional expense to the parent or caregiver.*
 - *The above information may be disclosed to the Proprietor or his/her agent for the purposes of attendance dues.*

I/We understand that being placed on the waiting list DOES NOT guarantee enrolment but means that my child's application will be considered when a place becomes available.

I/We understand that information collected by the school will be used to help meet my child's educational/pastoral needs and to comply with Ministry of Education and other legislative requirements within the provisions of the Privacy Act 1993.
